## A. Presentation of 2018 Financial Statement (Stephen M. Gay, CPA):

Mr. Gay presented a draft copy of the 2018 Financial Statement, to the IDA Board Members for review. Mr. Gay, explained to the Board, that according to Ms. Vanderhyde (Finance Director) and the County Auditors, Robinson Farmer Cox & Assoc., to be consistent with their books, Mr. Gay must include in his statement, on January 30, 2018, the Authority issued a \$1,803,802, tax-exempt bond, bearing interest at 3.59%, mature on June 30, 2028. A revised copy will be submitted to the Board.

#### B. Approval and Payment for VACORP 2019-2020 Insurance:

DRF, funds not to exceed \$377,500, for the purpose of purchasing certain manufacturing equipment by the IDA for lease to Panacea Biomatx, Inc. ("Panacea"), which purchase is also financed through a loan from First Citizens Bank and Trust ("First Citizens"). Motion carried unanimously.
