Section 17-18 (c) of the Pittsylvania County Solid Waste Disposal Ordinance provides for an exemption to the Solid Waste Disposal Fee for Uninhabitable Dwellings. An uninhabitable dwelling is one that is not suitable to live in. The Building Official will determine that a dwelling is eligible for the fee exemption if it is found to be uninhabitable due to conditions such as the following:

- No heating system
- No functional water or sewer system
- Not structurally sound or safe for human occupancy
- No operable electrical system or a disconnected electrical meter

The determination of inhabitability will require a site visit by a Building Inspector. There is a \$20.00 non-refundable fee per parcel for this site visit and inspection. This fee must be paid prior to an inspection visit being scheduled.

Please note that a livable dwelling that is currently vacant is not eligible for the fee exemption because it could be occupied at any time.
